Assuming continued employment, the Restricted Stock Units held by the Reporting Person will vest and be paid out as follows: 10,857 on October 31, 2013; 9,711 on October 31, 2014; 6,240 on November 2, 2015; 8,874 on November 16, 2015; and 3,550 on October 31, 2016. Upon payout, shares will be withheld to cover minimum statutory tax obligations. Restricted Stock Units are accompanied by dividend equivalent rights that will be payable in cash at the time of payout of the related shares.
