- o Confirmation of all securities held by Smith Barney.

- o Agreement of three security purchases, two security sales and one repayment since our last report from the books and records of the Company to the Company's bank statements.

We believe that our examination provides a reasonable basis for our opinion. Our examination does not provide a legal determination on the Company's compliance with specified requirements.
