This percentage was calculated by dividing (i) (A) the total amount of Shares beneficially owned by the Reporting Persons, plus (B) the total amount of Shares issuable upon exercise of certain warrants beneficially owned by the Reporting Persons, by (ii) (x) the total number of Shares outstanding as reported by the Issuer in the Quarterly Report, plus (y) the total amount of Shares issuable upon exercise of certain warrants beneficially owned by the Reporting Persons.
