Item 1. Security and Issuer

This Schedule 13D relates to shares of the common stock, \$.001 par value per share, of DecisionPoint Systems, Inc., a Delaware corporation (the "Company"). The address of the principal executive office of the Company is 8697 Research Drive, Irvine, CA 92618.

Item 2. Identity and Background

- (a) This statement is being filed by Donald W. Rowley (the "Reporting Person").
- (b) The Reporting Person's principal business address is 25501 Arctic Ocean Drive, Lake Forest, CA 92630.
- (c) The Reporting Person's present principal occupation is Chief Executive Officer of iTEK Holding, Inc, 25501 Arctic Ocean Drive, Lake Forest, CA 92630.
- (d) During the last five years, the Reporting Person has not been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors).
- (e) During the last five years, the Reporting Person has not been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violations with respect to such laws.
- (f) Citizenship: United States.

Item 3. Source and Amount of Funds or Other Consideration

Pursuant to a certain stock purchase agreement, dated as of October 12, 2012, by and between Sigma Opportunity Fund II, LLC and the Reporting Person, the Reporting Person purchased from Sigma Opportunity Fund II, LLC 58,800 shares of common stock and 154,400 shares of Series C Preferred Stock of the Company for an aggregate purchase price of \$494,080.

The source of funds was personal savings and liquid investments.

On November 15, 2012, the Company issued 35,073 shares of common stock to the Reporting Person as an antidilution adjustment.

Item 4. Purpose of Transaction

The shares of the Company were acquired by the Reporting Person for investment purposes.

Item 5. Interest in Securities of the Issuer

- (a) As of the date hereof, the Reporting Person beneficially owns 685,352 shares of the Company's common stock, of which 88,458 are issuable upon conversion of preferred stock, which represents approximately 7.5% of the Company's common stock.

- (b) The Reporting Person may be deemed to hold sole voting and dispositive power over 685,352 shares of common stock of the Company.
- (c) Other than the acquisition of the shares as reported herein, and as described under Item 4, the Reporting Person has not effected any transactions in the shares of the Company during the past 60 days or since the most recent filing of Schedule 13D, whichever is less.
- (d) To the best knowledge of the Reporting Person, no person other than the Reporting Person has the right to receive, or the power to direct the receipt of, dividends from, or the proceeds from the sale of the 685,352 shares of common stock reported in Item 5(a).
- (e) Not applicable.
