**PEACE ARCH ENTERTAINMENT CLOSSES ACQUISITION AND FINANCING
TRANSACTIONS**

Vancouver, British Columbia Peace Arch Entertainment Group Inc. ("Peace Arch") (AMEX: "PAE"; TSE: "PAE.A", "PAE.B"), a leading independent television production company in Canada, announced that on January 31, 2003 it closed the acquisition, financing and debt restructuring transactions previously described in news releases dated January 22, 2003 and December 18, 2002. Pursuant to the transactions, the Company issued an aggregate of 13,333,333 Class B Subordinate Voting Shares at a price of \$0.30 per share and reserved for issuance 2,863,000 Class B Subordinate Voting Shares. The reserved shares relate to Conversion Rights Certificates that grant the holders the right to convert indebtedness at prices no less than \$3.00 per share and no greater than \$5.00 per share in approximately two to three years from the closing date.
