**MTS Announces Subscriber Growth Numbers for September 2005**

**Moscow, Russian Federation October 10, 2005 Mobile TeleSystems OJSC ( MTS - NYSE: MBT), the largest mobile phone operator in Russia and the CIS, announces that its consolidated subscriber base reached 50.36 million users on September 30, 2005.**

During September 2005, MTS consolidated subscriber base increased by 2.03 million subscribers, of which 1.57 million were added in Russia.
