Item 1.01 Entry into a Material Definitive Agreement.

On June 25, 2008, we entered into a Purchase Agreement, as amended on December 11, 2008, June 25, 2010, July 26, 2010, September 15, 2010 and October 15, 2010 with certain accredited investors (the Investors) pursuant to which we sold an aggregate of \$600,000 of 10% Senior Secured Convertible Notes (the Notes). On November 15, 2010, the Investors amended the Notes to extend the Stated Maturity Date to November 30, 2010. We believe the Investors will continue to work with our Company to reach a positive outcome on the Note repayment.
