- Shares were awarded pursuant to the amended and restated 2002 Non-Employee Director Stock Plan. The shares are subject to forfeiture and are non-transferable until vested. The shares vest in three (3) annual installments from the date of grant. Twenty five percent (25%) of the shares vest upon the first and second anniversary, the remaining fifty percent (50%) vests on the third anniversary of the date of grant.
- This number includes 129,335 restricted shares awarded pursuant to the amended and restated 2002 Non-Employee Director Stock Plan.
- (1) These shares remain subject to forfeiture and are nontransferable until vested. The shares vest over either three (3) or four (4) years from the date of grant.
 - (2) The sale price represents the weighted average sales price of individual sales totaling 2,290 shares in the aggregate. The transactions occurred at prices in the range of \$16.91 per share to \$17.00 per share. Upon request from the Securities and Exchange Commission or a securityholder of the issuer, full information regarding the number of shares sold at each separate price will be made available.
