#### ARES CAPITAL CORPORATION PRICES PUBLIC OFFERING

New York, NY September 26, 2013 Ares Capital Corporation (Nasdaq: ARCC) announced that it has priced its public offering of 11,000,000 shares of its common stock. Ares Capital has granted the underwriters an option to purchase up to an additional 1,650,000 shares of common stock. The offering is subject to customary closing conditions and is expected to close on October 1, 2013. The offering of the shares is being made under Ares Capital's shelf registration statement (as amended), which was filed with, and declared effective by, the Securities and Exchange Commission. On September 25, 2013, the official close price of Ares Capital's common stock on The NASDAQ Global Select Market under the symbol ARCC was \$17.55 per share.

Ares Capital expects to use the net proceeds of this offering to repay certain outstanding indebtedness under its debt facilities and, to the extent not used for such purpose, for general corporate purposes, which may include investing in portfolio companies in accordance with its investment objective.

The underwriters may offer the shares of common stock from time to time for sale in one or more transactions on The NASDAQ Global Select Market, in the over-the-counter market, through negotiated transactions or otherwise at market prices prevailing at the time of sale, at prices related to prevailing market prices or at negotiated prices.
