- This Form 4 is being jointly filed by Bay Resource Partners, L.P., a Delaware limited partnership (Bay), Bay II Resource Partners, L.P., a Delaware limited partnership (Bay II), Bay Resource Partners Offshore Master Fund, L.P., an exempted limited partnership organized under the laws of the Cayman Islands (Offshore Fund), GMT Exploration Company LLC, a Delaware limited liability company (GMT Exploration). The foregoing persons are hereinafter sometimes collectively referred to as the Reporting Persons.
- (1) GMT Capital, the general partner of Bay and Bay II, has the power to direct the affairs of Bay and Bay II, including the voting and disposition of shares. As the discretionary investment manager of the Offshore Fund and certain other accounts, GMT Capital has power to direct the voting and disposition of shares held by the Offshore Fund and such accounts.
 - (2) The aggregate number of shares of common stock purchased was 148,300 shares and such shares were purchased by the Reporting Persons in the following amounts: Bay = 35,400 shares; Bay II = 36,000 shares; Offshore Fund = 76,900 shares.
 - (3) 14,298,400 shares of common stock is the aggregate number of shares of common stock owned by the Reporting Persons and is owned as follows: Bay = 2,260,200 shares directly owned by it; Bay II = 4,196,400 shares directly owned by it; Offshore Fund = 7,841,800 shares directly owned by it.
