- (1) Represents an award of restricted share units granted on February 11, 2009.

- (3) The amount includes approximately 157 shares acquired via dividend reinvestment during 2008 pursuant to a dividend reinvestment plan, sponsored by a broker-dealer, that essentially mirrors a dividend reinvestment plan sponsored by the registrant.
- (4) These underlying shares were acquired on a periodic basis by the trustee of the Company's tax qualified Profit Sharing (401(k)) and/or Supplemental Deferred Compensation Plan. The information was obtained from the plan administrator as of a current date. The number of shares is based on the account balance of the Company stock fund under each Plan (which includes some money market instruments) divided by the market price of the Company stock as of that date.
- (5) The options vest in three equal annual installments beginning on the first anniversary of the date of grant.
- (6) The plan pursuant to which the stock options were granted has been amended, subject to approval of the Issuer's stockholders, to provide for a maximum option term of ten years from the grant date. If stockholders fail to approve the plan amendments at the 2009 annual meeting of stockholders, the term of the options reported on herein will revert to seven years (so that the expiration
