- (1) Fractional shares were paid in cash upon scheduled vesting and settlement of restricted stock units which settled 100% in stock.
- (2) Each restricted stock unit represents one share of CIT common stock.
- (3) RSU's are scheduled to vest in three equal installments on the first, second and third anniversaries of the date of grant and are payable 50% in shares of CIT common stock and 50% in cash. The cash payment shall be based on the closing price of CIT common stock on the vesting date.
- (4) Deferred share units ("DSU") will expire and settle in shares of common stock upon filer's departure from the Board.
- (5) Each Deferred Share Unit is the economic equivalent of one share of CIT common stock.
- (6) Filer elected to defer issuance of stock until he is no longer a member of the Board.
- (7) Each restricted stock unit ("RSU") had the economic equivalent of one share of CIT common stock.
