- (2) Between May 4, 2013 and December 6, 2013, the reporting person acquired 166 shares of Chevron Common Stock under the Chevron Employee Savings Investment Plan, a 401(k) plan.
- (3) This number includes dividend equivalent accruals (434 shares).
