Vesting start date is June 2, 2010.
- (10) 1/48th of GSUs vested on July 25, 2012 and an additional 1/48th will vest monthly on the 25th day of each month thereafter, subject to continued service on such dates.
 - (11) 1/48th of the grant will vest on July 25, 2013 and an additional 1/48th will vest monthly on the 25th day of the month thereafter, subject to continued employment on such vesting dates.
 - (12) There is no exercisable date for the Issuer's Class B Common Stock.
 - (13) There is no expiration date for the Issuer's Class B Common Stock.
