- (1) On February 23, 2010, Mr. Rojek was awarded 100,000 shares of restricted stock of GLG Partners, Inc. ("GLG") (the "2010 Award") under GLG's 2009 Long-Term Incentive Plan (the "2009 LTIP"). The shares of restricted stock under the 2010 Award vest in three equal installments on May 15, 2010, 2011 and 2012.
- (2) Includes shares of restricted stock of GLG awarded to Mr. Rojek by GLG on March 18, 2008 and March 18, 2009 under GLG's 2007 Long-Term Incentive Plan, which are subject to vesting.
- (3) On February 23, 2010, Mr. Rojek was awarded shares of restricted stock of GLG (the "2009 Bonus Award") under the 2009 LTIP in the original amount of 48,839 shares, which represent a portion of Mr. Rojek's annual bonus compensation for 2009 under the Company's deferred remuneration arrangement. The shares of restricted stock under the 2009 Bonus Award vest in two equal installments on March 31, 2011 and 2012.
