Dividend equivalents accrued as a result of a cash dividend paid on January 21, 2011. 2,000 Restricted Stock Units ("RSU's") were granted on December 4, 2008 and vest one-third each year beginning on December 6, 2009. Each RSU represents the contingent right to

(1) receive one share of common stock upon vesting. Each RSU also accrues dividend equivalents on each date that Aceto pays a cash dividend to holders of common stock generally. RSU's attributable to such dividend equivalents are subject to the same terms and conditions as the RSU's to which such dividend equivalents relate.

(2) Dividend equivalents were erroneously reported as 16 shares of Restricted Stock Units. the correct amount is 8.
