Genco Shipping & Trading Limited (the "Company") has determined that it is unable to file its Quarterly Report on Form 10-Q for the quarterly period ended September 30, 2014 in a timely manner. As discussed in the Current Reports on Form 8-K filed by the Company on April 21, 2014 and July 15, 2014, the Company and its subsidiaries other than Baltic Trading Limited and its subsidiaries filed voluntary petitions for relief (the "Chapter 11 Cases") under Chapter 11 of the United States Bankruptcy Code in the United States Bankruptcy Court for the Southern District of New York and emerged from Chapter 11 on July 9, 2014. Due to the demands associated with the Chapter 11 Cases, the Company's emergence from

Chapter 11, and related activities including the application of fresh start accounting, despite diligent efforts, the Company has been unable to complete the preparation, review, and filing of its Quarterly Report on Form 10-Q within the prescribed time period without unreasonable effort and expense. The Company anticipates filing its Quarterly Report within the additional time provided by the filing.

Since the Company emerged from bankruptcy during the quarter ended September 30, 2014, the Company will present the period from July 1, 2014 to July 9, 2014 as the Predecessor period and the period from July 9, 2014 to September 30, 2014 as the Successor period. The amounts reflected below combine the results of both the Predecessor and Successor periods for the three months ended September 30, 2014.

The Company expects to report the following results of operations for the quarterly period ended September 30, 2014: voyage revenues are expected to decrease to approximately \$48.0 million for the three months ended September 30, 2014 compared to \$58.6 million for the prior year period. The Company expects its net income for the three months ended September 30, 2014 to be approximately \$870.7 million compared to a net loss of \$37.0 million for the prior year period. The significant change in the Company's net income for the period ended September 30, 2014 as compared to the corresponding period ended September 30, 2013 is attributable to the application of fresh start accounting required upon the Company's emergence from bankruptcy on July 9, 2014. Included in net income for the three months ended September 30, 2014 is an estimated net gain of \$901.2 million in reorganization items.

Voyage expenses are expected to increase to approximately \$2.5 million for the three months ended September 30, 2014 compared to \$2.2 million for the prior year period. Vessel operating expenses are expected to increase to approximately \$30.2 million for the three months ended September 30, 2014 compared to \$27.5 million for the prior year period. For the three months ended September 30, 2014, the Company expects to report an operating loss of approximately \$25.0 million compared to an operating loss of \$13.4 million for the prior year period.

The foregoing information is based on the Company's preliminary estimates of its results of operations for the quarterly period ended September 30, 2014 and anticipated changes from the prior year period. The Company's estimates are subject to change, and actual results may differ significantly from these estimates.
