- (1) Since the reporting person's last report, 3,334 shares granted by Stock Award II on September 23, 2015 vested immediately and are now owned directly.

All unvested award shares after the fourth vesting date will be forfeited.
 - (3) Stock Awards granted pursuant to the SI Financial Group, Inc. 2012 Equity Incentive Plan vest in four equal annual installments commencing on October 24, 2013.
 - (4) Stock Options are fully vested and exercisable.
 - (5) Stock Options granted pursuant to the SI Financial Group, Inc. 2005 Equity Incentive Plan vest in five equal annual installments commencing on February 16, 2012.
 - (6) Stock Options granted pursuant to the SI Financial Group, Inc. 2012 Equity Incentive Plan vest in five equal annual installments commencing on October 24, 2013.
