#### **Novo Nordisk A/S – Share repurchase programme**

**Bagsværd, Denmark, 4 August 2016** – On 29 April 2016, Novo Nordisk initiated a share repurchase programme under the provisions of the European Commission’s regulation no. 2273/2003 of 22 December 2003 and in accordance with Article 5 of Regulation No. 596/2014 of the European Parliament and Council of 16 April 2014 (MAR), also referred to as the Safe Harbour rules. This programme is part of the overall share repurchase programme of up to DKK 14 billion to be executed during a 12-month period beginning 3 February 2016.

Under the programme initiated 29 April 2016, Novo Nordisk will repurchase B shares for an amount up to DKK 3.5 billion in the period from 29 April 2016 to 3 August 2016. The programme is now concluded.

Since the announcement as of 1 August 2016, the following transactions have been made under the programme:

With the transactions stated above, Novo Nordisk owns a total of 21,717,648 B shares of DKK 0.20, corresponding to 0.9% of the share capital, as treasury shares. The total amount of A and B shares in the company is 2,550,000,000 including treasury shares.

Novo Nordisk expects to repurchase B shares for an amount up to DKK 14 billion during a 12-month period beginning 3 February 2016. As of 3 August 2016, Novo Nordisk has repurchased a total of 19,786,003 B shares equal to a transaction value of DKK 7,129,554,489.
