### Item 5.02 Departure of Directors or Principal Officers; Election of Directors; Appointment of Principal Officers.

On February 23, 2007, the Board of Directors of Heartland, Inc. (the Company ) elected to terminate Robert Cox, the Chief Executive Officer of the Company. The Company advised Mr. Cox of the same on February 26, 2007.

### Item 8.01 Other Events

On September 12, 2005, the Company entered into a Letter of Intent with the shareholder of NKR, Inc., d.b.a. Ohio Valley Lumber, a Delaware corporation ( Ohio Valley Lumber ), which was amended on November 30, 2006. On February 23, 2007, the Board of Directors of the Company, after reviewing the due diligence on Ohio Valley Lumber, elected to terminate the Letter of Intent and not proceed with the acquisition of Ohio Valley Lumber. On February 26, 2007, the Company notified Ohio Valley Lumber and the shareholder that the Letter of Intent has been terminated.
