Advisors V, LLC, which, in turn, is wholly owned by Thomas H. Lee Partners, L.P. The reporting person is a Managing Director of Thomas H. Lee Partners, L.P. As such, the reporting person may be deemed to beneficially own the shares of the Issuer owned directly by each of the Funds, Cayman Fund and Investors.
