- (1) This amendment is being filed to include an additional warrant to purchase 9,923 shares of SCM Microsystems, Inc. common stock for an exercise price of \$3.03 per share which is beneficially owned by the reporting person, that was not reported on the original Form 3.
- The securities reported herein were acquired pursuant to a merger between Hirsch Electronics Corporation and Deer Acquisition, Inc., a wholly-owned subsidiary of SCM Microsystems, Inc., in which each outstanding warrant to purchase shares of Hirsch Electronics Corporation was converted at the effective time of the merger into the right to receive a warrant to purchase shares of SCM
- (2) Microsystems, Inc. common stock with a five year term, exercisable for two years following the third anniversary of the effective time of the merger. The number of shares and the per share exercise price was determined by applying a conversion ratio to the warrants to purchase shares of Hirsch Electronics Corporation as provided for in the merger agreement. The merger closed on April 30, 2009.
