- (1) Shares held in trust with Mr. Lipps' wife.

- (4) period. The number of units that vest may be 0% to 120% of the target number of units, depending upon performance. The maximum number of units that may vest is 43,340. Vested restricted stock units will be paid in an equal number of shares of the Omnicell's common stock.

- (5) Shares vest ratably over 48 months, with a 1 year cliff.
