- (5) On 12/10/14 the reporting person was granted 40,150 restricted stock units ("RSUs"), 13,383 of which will vest on each of 12/10/15 and 12/10/16, and 13,384 of which will vest on 12/10/17. Dividend equivalent rights accrue with respect to these RSUs when and as dividends are paid on HP common stock.
