Item 7.01. Regulation FD Disclosure

On April 13, 2006, Casey's General Stores, Inc. (NASDAQ: CASY) reported March 2006 same-store sales results for stores open for one full year. Same store gasoline gallons sold decreased 1.5% in March 2006 compared to March 2005. Relative to the Company's annual goal, the gasoline margin continued to be under pressure during the month. The average retail price of gasoline sold during March 2006 was \$2.39 per gallon. Same-store sales of grocery and other merchandise increased 3.9% and prepared food and fountain same-store sales increased 9.6% in March 2006 compared to March 2005.
