(1) Represents dividend equivalent rights earned under the Equity Incentive Plan as part of a grant of restricted stock units.

Of the 13,916 shares owned directly, 9,193 are restricted stock units including dividend equivalent rights, approximately 54 shares were received pursuant to the Company's 401(k) plan between February 28, 2007 and the date hereof, and approximately 4 shares were received pursuant to an automatic dividend reinvestment feature handled through the reporting person's broker.

An adjustment of 27 fewer shares has been made to the total number of restricted stock units, and an adjustment of 4 additional shares has been made to the total number of shares beneficially owned by the reporting person. The adjustments were made to reconcile (3) discrepancies between what was reported previously and the actual number of shares as determined by a recent review of the Company's records. It is believed that the discrepancy in the numbers reported are the result of rounding and discrepancies in calculations made of the total shares held.
