- (1) On July 1, 2008, Encore issued 3,110 deferred issuance restricted stock units ("RSUs") to Mr. Wilcox under the Encore 2005 Stock Incentive Plan in connection with Mr. Wilcox' service on Encore's board of directors.
- These shares are in the form of RSUs held by Mr. Wilcox. Each RSU represents the right to receive one share of Encore common stock upon settlement. 3,600 of these RSUs will vest on December 14, 2008. Another 3,600 of these RSUs will vest on November 14, 2009. The remaining 6,217 of these RSUs are fully vested.
