In a Form 4 filed December 17, 2009, it was reported that A. Damian Perl, as a non-employee director of the Issuer, was granted 3,845 restricted shares by the Issuer on December 16, 2009, with such shares scheduled to vest in three equal, annual installments beginning on the first anniversary of the grant date. This amendment is being filed to reflect the fact that instead of receiving such restricted shares, A. Damian Perl will receive cash in an amount equal to the value of such restricted shares, as determined under FAS 123 as if such shares had been granted on December 16, 2009.

These shares are owned by Contego Systems LLC ("Contego"). Contego is wholly owned and managed by Kende Holding kft ("Kende").

- (2) Kende is 99.98% owned and controlled by Global Strategies Group Holding, S.A. ("GLOBAL"). GLOBAL is controlled by A. Damian Perl.
