 The amount reported represents the number of shares tendered by the reporting person in the Company's tender offer. Due to the tender offer being oversubscribed, the Company expects to purchase only a prorated portion of the shares properly tendered by each tendering shareholder. Based on a preliminary count, the Company has been informed by the depositary for the tender offer that the preliminary proration factor for the tender offer is approximately 99.4%, which would result in the reporting person selling 18,091 shares. An amended Form 4 will be filed regarding the number of shares actually sold by the reporting person in the tender offer following the Company's announcement of the final results of its tender offer.
