(1) As provided in the Issuer's Amended and Restated Certificate of Incorporation, each share of Class B Common Stock is convertible at any time, at the option of the holder, into one share of Class A Common Stock. In addition, each share of Class B Common Stock will convert automatically into one share of Class A Common Stock upon any transfer, whether or not for value, except for certain permitted transfers described in the Issuer's Amended and Restated Certificate of Incorporation.

(2) On December 31, 2013, the Reporting Person contributed 6,989,003 shares of Class B Common Stock to THHC, L.L.C in exchange for membership interests in THHC, L.L.C. No cash consideration was paid in connection with the contribution. The contribution of shares of Class B Common Stock by the Reporting Person constitutes a "permitted transfer" as defined under the Issuer's Amended and Restated Certificate of Incorporation. Accordingly, immediately following the contribution, the shares remain shares of Class B Common Stock.
