Of the grant of restricted stock, 75% is subject to vesting based on GEO's total shareholder return over a three-year period and 25% is subject to vesting based on certain return on capital employed performance goals being met.
  - (2) The amount of shares has been adjusted to reflect the September 1, 2013 vesting of 1,728 shares of restricted stock.
