- (1) 1,472 shares were withheld from the 4,500 restricted shares that vested on May 20, 2014. These 1,472 shares represent the value of the taxes required to be withheld pursuant to applicable employment or tax laws, as determined by the Issuer. These 4,500 shares were awarded to Mr. Chapman on May 20, 2010. These vested shares were valued at the NYSE closing market price on May 20, 2014.
- (2) 14,700 of these Common Shares are restricted. The restrictions on these Common Shares lapse as follows: 3,700 on June 1, 2015; 5,000 on May 31, 2016 and 6,000 on May 31, 2017.
- (3) These shares are held in The Sharon A. Chapman 2007 Amended & Restated Revocable Trust UAD 7/20/2007 for the benefit of the Reporting Person's spouse. The Reporting Person and the Reporting Person's spouse are co-trustees of the trust. The Reporting Person disclaims beneficial ownership of these securities, except to the extent of his pecuniary interest therein.
