- (1) 399 shares were withheld from the 1,200 restricted shares that vested on May 20, 2014. These 399 shares represent the value of the taxes required to be withheld pursuant to applicable employment or tax laws, as determined by the Issuer. These 1,200 shares were awarded to Mr. Zangerle on May 20, 2010. These vested shares were valued at the NYSE closing market price on May 20, 2014.
