This amended Form 4 is being filed solely to correct the reported amount of shares acquired on May 27, 2014. Restricted Stock Units (1) awarded to reporting person under the 2011 Omnibus Incentive Plan. Each RSU represents a contingent right to receive one share of common stock. The RSUs vest in 4 equal annual installments commencing on May 27, 2015.

This amended Form 4 is being filed solely to correct the reported amount of shares acquired on May 27, 2014. The Reporting Person was awarded performance-based RSUs determined based on attainment of established financial metrics for the two-year period ending (2) January 31, 2016. The Maximum level performance-based RSU award is 6,696. Based on actual performance, the award can range between zero and 100% of the Maximum award. Each RSU represents a contingent right to receive one share of common stock. 50% of the RSUs vest on May 27, 2016, 25% of the RSUs vest on May 27, 2017 and 25% of the RSUs vest on May 27, 2018.
