(1) Transaction effected pursuant to Rule 10b5-1 trading plan adopted by the reporting person on March 8, 2013.

(2) The sale relates to shares underlying stock options that are scheduled to expire next month (May 3, 2015). The price of \$28.14 represents the weighted average of fifteen open-market sale transactions ranging in price from \$27.90 to \$28.28.
