Unilever NV also announces that 18,681 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 66,938,637 Unilever NV ordinary shares in treasury, and has 1,647,789,063 Unilever NV ordinary shares in issue (excluding treasury shares).
