Unilever NV announces that on 10 September 2007 it purchased 500,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 21.930 and euro 22.220 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 10,276 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 92,933,123 Unilever NV ordinary shares in treasury, and has 1,621,794,577 Unilever NV ordinary shares in issue (excluding treasury shares).
