Unilever NV announces that on 3 April 2008 it purchased 300,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 21.430 and euro 21.580 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 8,103 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 150,058,892 Unilever NV ordinary shares in treasury, and has 1,564,668,808 Unilever NV ordinary shares in issue (excluding treasury shares).
