Attached is an English translation of the summary of the letter dated on October 23, 2003 filed by Company with the *Bolsa de Comercio de Buenos Aires* and the *Comisión Nacional de Valores*.

By letter dated October 23, 2003, the Company reported that a holder of Company's Convertible Notes exercised his conversion right. Hence, the Company shall issue 137,849 shares, face value pesos 1 (V\$N 1) each, and cancel Convertible Notes for an amount of U\$S 70,000. The conversion was performed according to terms and conditions established in the prospectus of issuance at the conversion rate of 1.96928 shares, face value pesos 1 per Convertible Note of face value U\$S 1. As a result of that conversion the amount of shares of the Company goes from 125,080,466 to 125,218,315. On the other hand, the amount of registered Convertible Notes is U\$S 49,675,753.
