The Registrant expects to report net revenues of approximately \$1,555,000 for the three months ended June 30, 2005, as compared to approximately \$2,304,000 for the three months ended June 30, 2004. Net loss for the three months ended June 30, 2005 is expected to be approximately \$765,000 as compared with approximately \$513,000 for the three months ended June 30, 2004. Underlying these results are expected operating expenses of approximately \$1,464,000 for the three months ended June 30, 2005, as compared to approximately \$2,090,000 for the three months ended June 30, 2004.

The Registrant expects to report net revenues of approximately \$3,477,000 for the six months ended June 30, 2005, as compared to approximately \$4,604,000 for the six months ended June 30, 2004. Underlying these results are expected operating expenses of approximately \$2,978,000 for the six months ended June 30, 2005 as compared to approximately \$3,912,000 for the six months ended June 30, 2004.
