**Item 8.01. Other Events.**

At the UBS 10th Annual Global Communications Conference on November 17, 2005, Doreen Toben, Executive Vice President and Chief Financial Officer of Verizon Communications Inc., provided an outline of the company's strategic focus. She discussed Verizon's strategies and competitive advantages in four key areas of growth: wireless, broadband, video and the enterprise market. She stated that sales of Verizon's DSL broadband service were continuing the momentum achieved in the 3rd quarter, and the company expects to finish the 4th quarter with very strong DSL results. Ms. Toben commented on the possibility of reducing the number of access lines following the MCI merger. The company is currently considering alternatives and will make an announcement when it determines its course of action.
