**Outcome of Share Repurchase**

**TOKYO, JAPAN, November 12, 2007** NTT DoCoMo, Inc. announced today the following outcome of its share repurchase under Article 156 of the Company Law.

**1. Reason for share repurchase**

To improve capital efficiency and to implement flexible capital policies in accordance with the business environment.

**2. Details of share repurchase**

- (1) Class of shares: Common stock
- (2) Period for share repurchase: From October 29, 2007 to November 12, 2007
- (3) Aggregate number of shares repurchased: 117,653 shares
- (4) Aggregate price of shares repurchased: 19,999,268,000 yen
- (5) Method of repurchase: Purchase on the Tokyo Stock Exchange

The above repurchase of shares was approved by DoCoMo's shareholders at the 16th annual general meeting of shareholders, which was held on June 19, 2007. The summary of the resolution is as follows:

-Class of Shares to be repurchased: Common Stock

-Aggregate number of shares to be repurchased: Up to 1,000,000 shares

-Aggregate price of shares to be repurchased: Up to 200,000,000,000 yen
