Of the 80,000 shares, First Montauk designated 70,000 to certain of its employees as demonstrated in the table appearing under the heading "Selling Stockholders." In compliance with FINRA Rule 2710(g)(1), First Montauk and such employees agreed to a prohibition on their ability to exercise the warrants for a period of six months following the effective date of the registration statement to which this prospectus is a part.
