ITEM 1.01. ENTRY INTO A MATERIAL DEFINITIVE AGREEMENT.

On June 9, 2008, Heidrick & Struggles International, Inc. (the Company) and Scott Krenz entered into an employment agreement effective as of June 9, 2008 (the Agreement), pursuant to which Mr. Krenz agreed to serve as the Company's Executive Vice President and Chief Financial Officer.

Under the terms of the Agreement:

Mr. Krenz will receive an annual base salary of \$375,000.

Mr. Krenz will be eligible to receive an annual bonus with a target bonus opportunity of 100% of his base salary.

Mr. Krenz will receive a cash sign-on bonus of \$100,000 payable within thirty (30) business days of his employment start date or the next applicable payroll date that occurs thereafter.

On September 30, 2008, Mr. Krenz will be granted 5,000 restricted stock units with respect to shares of common stock of the Company, which restricted stock units will vest at a rate of one third on the first three anniversaries of the grant date, and, upon vest, will convert into shares of common stock on a one-for-one basis.

On September 30, 2008, Mr. Krenz will be granted an award of stock options to purchase 7,500 shares of common stock of the Company, which options will vest at a rate of one third on the first three anniversaries of the grant date, and will have a ten (10) year term with an exercise price equal to the closing price of a Company common share on September 30, 2008.

Mr. Krenz will participate in the Company's other benefit programs at the same level as such benefits are generally provided by the Company from time to time to other senior executives of the Company.

If the Company terminates Mr. Krenz's employment without Cause (as defined in the Agreement), the Company will provide Mr. Krenz with certain additional payments and benefits as set forth in the Agreement.

Mr. Krenz is prohibited from competing with the Company and soliciting the Company's customers during his employment and, under defined circumstances, for 12 months after termination.

Mr. Krenz is prohibited from soliciting any of the Company's employees, under defined circumstances, for a period of 12 months following termination.

The foregoing description of the Agreement does not purport to be complete and is qualified in its entirety by reference to the full text of the Agreement, a copy of which is attached as Exhibit 10.1, and incorporated by reference herein.

Mr. Krenz comes from Navigant Consulting, where he served as Executive Vice President and Chief Financial Officer. Before joining Navigant Consulting, Mr. Krenz was Chief Financial Officer at Sapien Corporation. Prior to that, Mr. Krenz held senior finance positions of increasing responsibility during a 19-year tenure at Electronic Data Systems Corporation (EDS). Krenz started his career in public accounting with Ernst & Whinney.
