By letter dated November 23, 2009, the Company reported that, during the recent period, certain holders of the Company s Warrants exercised their warrant rights to acquire additional shares. Hence, a reduction of 3,369 warrants and an increase of 1,123 ordinary shares of the Company face value pesos 1.00 (V\$N 1) each, was made.

As a result, the amount of shares of the Company increased from 501,538,610 to 501,539,733. The new amount of warrants outstanding is 177,705,104.

The exercise of the warrant was performed according to terms and conditions established in the prospectus of issuance, dated February 21, 2008, in connection with the Company s rights offering to subscribe for 180,000,000 common shares and 180,000,000 warrants to subscribe common shares, in which each warrant entitles its holder to purchase 0.333333333 common shares at a price of US\$ 1.68 for each share face value Ps.1.00.
