**Item 7.01 Regulation FD Disclosure.**

On October 4, 2011, Newport Corporation (the Registrant ) announced that it has completed the acquisition of Ophir Optronics Ltd. The Registrant also announced that it has obtained a \$250 million senior secured credit facility from a syndicate of global financial institutions to provide additional funding for this acquisition, the repayment of the Registrant's \$127 million of convertible subordinated notes maturing in February 2012, and other corporate purposes. The press release issued by the Registrant in connection with these announcements is attached to this report as Exhibit 99.1.
