**Item 5.07 Submission of Matters to a Vote of Security Holders.**

Targa Resources Corp. (the Company) held its 2012 Annual Meeting of Stockholders (the Annual Meeting) on May 25, 2012. At the Annual Meeting, the Company's stockholders were requested to: (1) elect three Class II Directors to serve on the Company's Board of Directors for a term of office expiring at the Company's 2015 Annual Meeting of Stockholders; and (2) ratify the selection of PricewaterhouseCoopers LLP as the Company's independent registered public accounting firm for 2012. The following are the final voting results on proposals considered and voted upon at the meeting, each of which is more fully described in the Company's proxy statement filed on April 4, 2012:

- Each of the three Class II directors that was up for re-election was elected for a term of three years. Votes regarding the election of these directors were as follows:

- PricewaterhouseCoopers LLP was ratified as the Company's independent registered public accounting firm for 2012. The voting results were as follows:
