On May 7, 2013, at a meeting of the board of directors (the Board) of Scott's Liquid Gold-Inc. (the Company), Jeffrey R. Hinkle, Jeffrey B. Johnson and Dennis H. Field (the Directors) informed the Board of their decision not to stand for reelection to the Board and to resign from the Board effective as of the next annual meeting. Mr. Hinkle currently serves as the Company's Executive Vice President of Corporate Development and Corporate Secretary and will continue to serve in these capacities.

None of the Directors resigned as a result of any disagreement with the Company or its management. The Company's Proxy Statement relating to the 2013 Annual Meeting, which was filed with the Securities and Exchange Commission today, contains important information regarding the Board's director nominees for election at the 2013 Annual Meeting. Following the 2013 Annual Meeting, the Board will consist of 5 directors.
