On May 14, 2013, CenturyLink, Inc. issued a press release announcing that its indirect wholly-owned subsidiary, Qwest Corporation, agreed to sell \$750 million aggregate principal amount of 6.125% Notes due 2053. Qwest Corporation also granted the underwriters an option to acquire up to an additional \$25 million principal amount of these notes solely to cover over-allotments.
