**Seaspan Announces Pricing of \$300 Million Public Offering of 6.375% Senior Notes**

Hong Kong, China, March 27, 2014 Seaspan Corporation (Seaspan) (NYSE:SSW) announced today that it has priced its previously announced \$300 million public offering of senior unsecured notes due 2019 (the Notes). The Notes will mature on April 30, 2019 and will bear interest at a rate of 6.375% per year, payable quarterly on each January 30, April 30, July 30 and October 30, beginning on July 30, 2014. Seaspan has granted the underwriters of the offering a 30-day option to purchase up to an additional \$45 million of the Notes on the same terms and conditions. The offering is expected to close on April 3, 2014.

Seaspan intends to use the net proceeds from the offering for general corporate purposes, which may include funding vessel acquisitions and repayment of indebtedness under outstanding credit facilities. Following the offering, Seaspan intends to file an application to list the Notes on The New York Stock Exchange.

Sterne, Agee & Leach, Inc. is acting as sole book-running manager and structuring agent for the offering. BB&T Capital Markets, DNB Markets, Incapital, Janney Montgomery Scott, Ladenburg Thalmann & Co. Inc., Wunderlich Securities, Maxim Group LLC, National Securities Corporation and Santander are acting as co-managers for the offering.

Seaspan's managed fleet consists of 105 containerships representing a total capacity of over 800,000 TEU, including 31 newbuilding containerships on order scheduled for delivery to Seaspan and third parties by the end of 2016. Seaspan's current operating fleet of 72 vessels has an average age of approximately seven years and an average remaining lease period of approximately five years.
